Bay Delta Conservation Plan

We had Solano County supervisor John Vasquez attend our Board meeting February 28. Mr. Vasquez is concerned about the Bay Delta Conservation (sic)Plan(BDCP). He brought some hand outs that he had received at the Solano County Water Agency meeting last month, that showed the areas that would be turned into "restoration opportunity area" from the California Water Code 85066. "Restoration" means the application of ecological principles to restore a degraded or fragmented ecosystem and return it to a condition in which its biological and structural components achieve a close approximation of its natural potential, taking into consideration the physical changes that have occurred in the past and the future impact of climate change and sea level rise. The Boat Club property is located in this area. The state definition doesn't sound very compatible with the Boat Club. That could mean the end of the Boat Club. We're one small part of the bigger picture. For those of you that don't know the BDCP is the new peripheral canal, but instead of the canal it is 2-40 foot tunnels, that would run from Clarksburg to the Clifton forebay near Tracy. These tunnels have the capacity to carry 15,000 cubic feet per second (c.f.s.) The average flow of the Sacramento River July thru November is 14,620 c.f.s. and the yearly average is 23,666 c.f.s.. That doesn't leave much water for the delta. Additionally this plan would take 28,000 acres of agriculture land out of production in Solano County, with the flooding of Hastings and Eggert Islands, a portion of Liberty Farms and the old Vassar ranch. Without the flushing of the delta provided by the Sacramento River the consensus, other than BDCP, is that the delta waters would become dirtier and saltier with some areas becoming stagnant and over all be more conducive to invasive species. The BDCP has largely been paid (to the tune of \$150 million) by Westlands Water District, the Los Angeles Metropolitan Water District and other water districts south of the Delta. Many of the same folks that sucked the Owens Valley dry. But wait there's more the cost is estimated to be \$23 billion and independent analyses have pegged it at \$47 billion which will be paid by a bond floated by the State. In other words you the tax payer will be paying.

If you have any feelings about all this, there will be a meeting at the Solano County Water Agency 810 Vaca Valley Parkway, Suite 203, Vacaville, Ca March 14, at 6:30 P.M.

Additionally Supervisor Vasquez has volunteered to come to our April membership meeting and further discuss

this plan with the members.

Bay Delta Conservation Plan

We had a presentation by our County Supervisors John Vasquez and Skip Thompson on some of the possible effects of the Bay Delta Conservation Plan (BDCP). Some highlights of the plan are:

1. They will flood 145 thousand acres (226 square miles) of farmland in Northern California, 45 thousand (70 square miles) just within Solano County.

2. They will have the capability to take more than the entire flow of the Sacramento river July through November and 6 tenths of the river flow the remainder of the year.

3. They will stockpile 1600 acres (2.5 square miles) 100' deep of polluted muck for ten years. This is the waste from the excavation for the pipelines.

4. This supposed "scientific study" has been paid for (\$200 million to date) by predominately Westland Water District,<u>http://www.indybay.org/newsitems/2011/12/1</u> <u>4/18702762.php</u> by Dan Bacher "*Westlands, the largest water district in the U.S., is known for the numerous lawsuits that they have launched against fish restoration on the Sacramento, San Joaquin and Trinity rivers and their continual lobbying of the state and federal governments for increased water exports from the*

California Delta. Corporate growers in the district, located on the west side of the San Joaquin Valley, use subsidized water from the federal Central Valley Project to irrigate drainage impaired land laced with selenium and other toxic salts " the Metropolitan Water District that in the twenty years prior to 2005 pumped 700 thousand acre feet per year but in 2009 projected that it would pump 1.2 million acre feet per year. I wonder if that's why they want the tunnels built? There are other water contractors involved just as greedy for water. 5. From http://www.restorethedelta.org/latest-bdcpeffects-analysis-nothing-more-than-a-rationale-for-aconveyan/ "The Brown Administration's latest attempt to justify its Peripheral Tunnels adds another to three previous failed Effects Analysis studies, which were savagely trashed by the National Science Academy as "nothing more than a rationale for a conveyance." This website is by far the most interesting reading of all the others, cataloging the degradation of the delta if these tunnels are allowed to be constructed.

What you can do to stop this process. Write your federal, state and local representatives, donate to groups such as Restore the Delta (link above), and attend the public meetings The next meeting is tentatively scheduled for the week of April 29.

Check out Congressman's Garamendi alternative delta plan at <u>http://garamendi.house.gov/press-release/congressman-garamendi-releases-comprehensive-water-plan-all-california</u>, a much more sensible approach.

Proposed SOP and Bylaws Changes

The following are proposed bylaws changes, with the rules for changes. They are proposed to make it quicker for new members to get in and to allow catch and release folks to get a mounted fish in the Clubhouse. Also to limit the fish to one that the club will pay for and display, and allow fish to be mounted that were caught by a members paid spouse or children under 18. The strikethroughs are to be deleted, and the italics (red for those getting by email) are additions to the existing bylaws.

Method of changing SOP

Section 1 The amendment process allows any voting member, at a regularly scheduled membership meeting to propose a written change or addition. The proposed change must be published in that month's newsletter so that all members are advised of same. At the next regular Membership meeting, with a quorum present, the change or addition shall be discussed and approved or denied by a majority vote of the members present.

Method of Changing Bylaws

Section 1 Members may move to amend these By-Laws at any time during a General Membership meeting. A majority vote is needed of the members attending, providing the Membership has been notified of the meeting and its purpose, at least five (5) days prior to the scheduled meeting.

These are proposed changes to the SOP's and Bylaws. Below is the original text of the existing rules. The proposed changes are in *red* and text to be deleted has a strikethrough-over the text.

Section 6 The allocated Membership enrollment number of the Dixon Boat Club will be discussed by the Board of Directors and their recommendations brought to the Membership for approval. Vacancies in the Club's enrollment may be filled at anytime providing the procedures regarding new members are followed as per Section 6 A, B, C & D of this Article. The dates of the two (2) consecutive mandatory meetings will be the only changes.

A: New member applications must be submitted to the Board by the Member/Sponsor. Applications will be dated and filed by the Club's Secretary. Upon the confirmation of Membership vacancies available after the March-February Membership meeting, the Secretary will notify the Sponsors and applicants with dates of the two (2) consecutive <u>mandatory</u> Membership meetings in <u>March April and May</u>, along with the initiation fee amounts, and obligations of the Sponsor and of the applicant. It is mandatory for both the Sponsor, and the applicant, to attend the <u>March Meeting</u>.

Section 6 A, B, C & D of this Article. The dates of the two (2) consecutive mandatory meetings will be the only changes.

A: New member applications must be submitted to the Board by the Member/Sponsor. Applications will be dated and filed by the Club's Secretary. Upon the confirmation of Membership vacancies available after the March Membership meeting, the Secretary will notify the Sponsors and applicants with dates of the two (2) consecutive mandatory Membership meetings in March <u>April and May</u>, along with the initiation fee amounts, and obligations of the Sponsor and of the applicant. It ismandatory for both the Sponsor, and the applicant, to attend the March Meeting.

At this meeting <u>April's General Membership meeting</u> for the Sponsor introduction introduces the applicant and the Membership votinges to approve or reject the applicant. A majority vote of the members present is needed to approve the new member's application. If either the Sponsor or the applicant fails to attend this mandatory meeting, the application into the Club will be denied. Upon Membership's approval, the applicant is instructed to appear at the next General Membership meeting in-If the applicant is approved, membership cards are assigned and the Club's By-Laws and boat stickers are handed out. Postponement requests for the March meeting due to unforeseen hardship, must reach the Board prior to the March Membership meeting. Postponements will be at the discretion of the Membership. May, to start the final induction process.

*****Note:** If the Sponsor cannot appear at the April's- March meeting due to unforeseen hardship, the Sponsor may submit a request to the Board of Directors, *before the February Board Meeting* with the name of a Co-Sponsor. The decision to except the designated Co-Sponsor or the request for hardship, will be at the discretion of the Board. If approved, the Co-Sponsor must appear with the new applicant at the April's March General Membership meeting. Non-appearance of the Co-Sponsor, will cause the new applicant's application to be denied. If the Sponsor's applicant can not appear at the mandatory meeting in May, due to unforeseen hardship, the application will be re-filed for enrollment the following year.

B. <u>May's General Membership meeting</u> is a mandatory meeting for the applicant. This is the final stage of the application where payments are made, Membership cards are assigned, and the Club's By Laws and boat stickers are handed out. Should the new applicant fail to appear at the *March* meeting, Membership will be denied. Postponement requests for the <u>May March</u> meeting due to unforeseen hardship, must reach the Board prior to the <u>May's March</u> Membership meeting. Postponements will be at the discretion of the Membership.

C. <u>Probation terms</u>: New Members will be subject to a one (1) year probationary period which includes the attendance of at least two (2) General Membership meetings. The probation period starts by attending the <u>May's</u> *March* General Membership meeting. Documentation of meeting attendance is required. Upon completion of the probation period, the new member will be eligible to hold an elective office, to hold a Chairperson's position, and to Sponsor new members. All other Membership benefits remain in service starting from the <u>May's *March* mandatory induction meeting</u>.

D. Application reviews by the Board of Directors will be based upon the Sponsors Membership record. Recommendations will be passed on by the Commodore to the Membership for discussion and approval.

EXAMPLE S FOR CLARIFICATION:

1. February March, the Secretary will send out Sponsor and applicant notifications.

2. *March-April* Mandatory Meeting where the Sponsor introduces the applicant. After Membership discussion, voting takes place, and starts the applicant's final induction process by paying all fees and receives Membership cards and Club By-Laws, etc. Attendance at this meeting initiates the probation period.

3. May's Mandatory Meeting starts the applicant's final induction process by paying all fees and receives Membership cards and Club By-Laws, etc. Attendance at this meeting initiates the probation period. Pg. 2 SOP's

Dues

Section 1 Membership dues shall be assessed and mailed out in December. Payment is due in full, *January 1* and must be received by the <u>February's Membership meeting</u>. Dues for a Primary member start at <u>\$140.00</u>, which includes Dinner Dance tickets. Payments not received by February's meeting, will be considered delinquent. A delinquent notice will be sent to the member with the added penalty fee of <u>\$50.00</u>. Members must pay all fees as so stated in the delinquent notice, by the <u>March Membership meeting</u>. Failure to pay by the <u>March - February</u> Membership meeting will be cause for expulsion from the Dixon Boat Club by the Board of Directors and will initiate a notice of expulsion. Special circumstances relative to personal hardship may be heard by the Board and must be initiated by the member prior to the <u>March February</u> Membership meeting. It will be incumbent upon the Purser to make documented contact with the Club member at least one week prior to the <u>March February</u> Membership meeting to insure that the member

is aware that their Membership is in jeopardy and of the payment deadline date. Recommendations by the Board will be brought to the March *February* Membership meeting for Membership discussion and approval. The Purser will accept payments at the General Membership meetings, or by mail to:

Example of Timeline:

A. December, members will be billed.

B. Payments not received by February's Membership meeting will be fined \$50.00.

B. C. Non-payment of dues and all delinquent fees by the February Membership Meeting will cause your Membership to be terminated.

Pg. 6 SOP's

A. <u>Fish Mounting</u>: The Membership of the Dixon Boat Club has agreed to the mounting of <u>one</u> Striped Bass over thirty (30) pounds, per member number while it is held by the existing member, this can be children 18 and under, spouse, or the primary member and to be paid for by the Membership .

Qualifications:

1. Must be caught by a member *or an immediate family member (as described above)* of the Dixon Boat Club.

2. The fish must be a legal catch.

3. Weigh at least 30 pounds.

4. Fish must be caught from boats launched from the Club's harbor.

5. Fish must be donated to the Dixon Boat Club.

6. If the member practices catch and release, the fish has to be weighed by, at a minimum 2 scales which can be verified against the Boat Club scale, the weighing must be witnessed by 2 independent members and the scales verified against the Boat Club scale by all witnesses on the return to the Boat Club. Additionally pictures must be taken to assist in the mounting.

7. These changes will take effect on the date approved by the membership. No fish caught prior to these changes will be considered for mounting.

8. If a member catches a larger fish, which he wishes to display at the Club grounds, he

may do so by paying all mounting fees, and replacing his existing fish at the Club. The new fish will henceforth belong to the Dixon Boat Club. The replaced fish shall

become the property of the member.

9. The Board shall decide where the work shall be done for any fish it is having mounted. **Plaque:**

1. Establish an enduring plaque for anyone catching a 30+ pound Striper. Which will be updated

at the end of the year by the Commodores Dinner sponsor and presented yearly at the Commodores Dinner.
